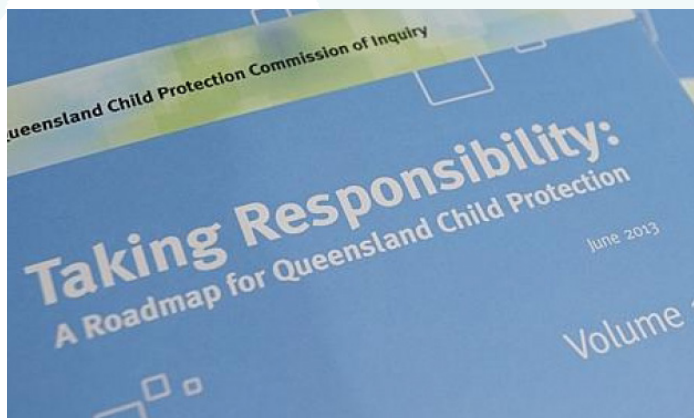

I want to hear from parents...

– Minister for Child Safety, Queensland.

On 1 June 2018, the Honourable Di Farmer MP, Minister for Child Safety, Youth and Women, and Minister for the Prevention of Family and Domestic Violence made an Australian-first announcement...

“We are committed to working with parents in developing the policies for this Department... to develop a formal committee for parents... and we can make sure that we are reflecting your views... to support you in the work that you do.” – Hon. Di Farmer MP.

Micah Projects is very proud that we have reached a new milestone in advocating and supporting the work of the Family Inclusion Network. It has been 15 years since we first formed the FIN,SEQ.

FIN strongly recommended that, from the outset, parents must lead the development of the model, mechanism or committee created.

“We wanted to avoid the risk of a tokenistic ‘pop up parent’ consultation around an already prepared solution.” – Susie Edwards, Coordinator, FIN,SEQ

1 June–October 2018

The Process

To the starting line and beyond!

Minister’s announcement, planning and recruiting

Follow ‘soft announcement’ by Minister (1 June) with Family Inclusion Network and local departmental planning, and parent outreach and recruitment.

Parent Forums were held in six trial locations: West End, Coorparoo, Wavell Heights, Townsville, Woodridge, Caboolture.



PARENT LED PROCESS

From November 2018, FIN sought to empower parents to share their experiences of the Queensland child protection system, to contribute ideas and solutions, and to help create an ongoing mechanism for hearing and heeding the collective voices of the parents.

Over four months, FIN met with or spoke with **42 interested parents** either face-to-face at small 'parent forums', or via telephone interviews.

WHAT DID WE ASK?

The first question explored was...

“Why was it important for you to come today?”

Then two discovery questions were unpacked...

“How might we design a permanent mechanism for parent engagement in Queensland’s child safety system?”

In this part of the conversation the focus was on the Minister’s desire to hear from parents: and ensuring parents had a say in the development of the type of model or mechanism or committee that was created. Many national and international studies emphasised that the method for hearing parents’ voices was just as significant as the subject matter raised by the parents (ie. ‘process’ and ‘content’ are both important).

“What is the most important feedback about the system that you would like to give?”

November–December 2018

Conduct 3 parent forums (Brisbane)

Local recruitment of 15–30 interested (not ‘representative’) parents for a series of parent engagement forums (Brisbane, then state-wide).

Parents needs met to attend (child-minding, transport, access).

February–March 2019

Conduct 5–6 parent forums (more regions)

Target 20-50 additional parents from rest of Queensland (46 offices/5 regions)

Questions for forum:

1. What is most pressing feedback from parents?
2. How might we co-design a permanent mechanism for parent engagement?

WHAT DID PARENTS SAY?

These are excerpts from over 400 comments available at finseq.org.au



"I'm here so that I can make a difference."

"This is so important, I've given up a day's work to be here ... \$300... maybe even lost a job.... because we feel so strongly about this."

"I've thought long and hard about what needed to be said today..."

"As a parent you want what's best for your kids."

"I think it's truly... truly a good idea! We really need to be listened to. I'd be jumping to get at the table!"

"Get groups of parents together in different areas, and then they feed their ideas into a state-wide group of family members and they then can talk to Local and Federal MP's."

"Something that stays current: what happened to me, won't be what happens to other parents in a year or two."

"An agenda that is manageable - slowly nibble away at change – just 2 things on the action plan – then ask for regular feedback at next meeting"

"Needs to be permanent."

"Once a year? 20-30 people?"

"Need to know that it's not going to bite you."

Some Issues

"So much judgement, expect to be a perfect parent... it is so much pressure"

"When you see the Affidavit!... WHAT?!?!? None of this happened!"

"I'm very very careful. I'm so careful – I make sure when I go to the Doctor to get a prescription, that I'm not there even one day too early."

"Little issues. One slip: one missed court appearance, one relapse... there's no room for any slip ups."

"Everything gets interpreted and changed... it should be written verbatim [to prevent misinterpretation]."

"I'm always wary; always under watch."

"I don't think there are enough staff and they're definitely over-worked. There needs to be people to facilitate. To support."

"Some of us have seen the system over a long time: we can recognise policy and legislation has changed to be more effective. But it's still not taking an empathetic approach to various situations which are often out of parents control, eg. both parents are punished for breaches of DVO; loss of housing or loss of income. A humanistic approach needs to be taken rather than the bureaucracy and silos of government or legal systems."

Some Solutions

"Have an easy to understand book for parents on the processes of child safety and family court."

"We could talk together... people who've been affected by the same thing. I can give some guidance and I empower them to stand up with me. We'll do this together."

"Need an independent worker – at each meeting."

"What helps parents? I tell them my story: you can do what I did. I'm there for you: from the beginning to the end. If you've fallen down – then reach out. I encourage them: step back up; you CAN do this."

Right: “From little things, big things grow” – words (and succulents) of thanks and inspiration for parents.

Opposite: Parents (and pets!) have cuppas, shed tears, and have a laugh or two... as they meet, build trust, and share unique expertise in improving the system.

To follow through on her vision, the Minister the Hon. Di Farmer, MP arranged to meet with some parents on the United Nations Global Day of Parents, Saturday 1 June 2019.

Eleven parents—a cross-section of parents with a range of experiences across the system, from a range of districts — prepared themselves for this meeting in Brisbane.

On 31 May 2019, in preparing themselves for their meeting with the Minister, the parents focused on three goals:

- » Summarise the key issues
- » Suggest a small number of solutions
- » Propose a model for the embedded, ongoing statewide parent advisory committee.

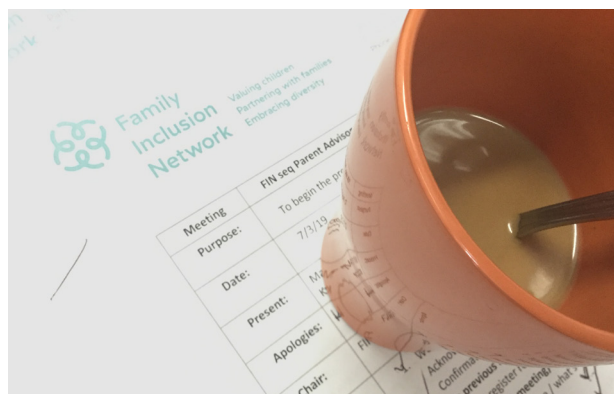
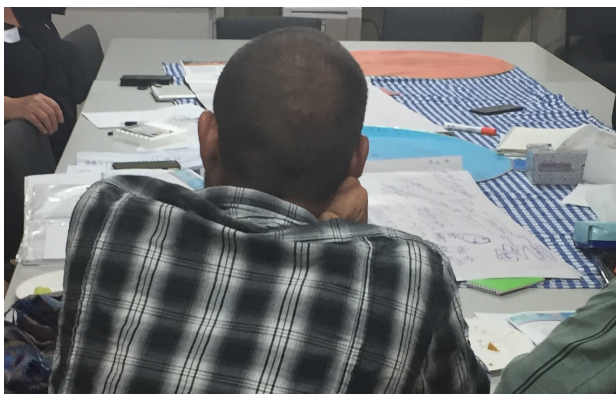

The “given”

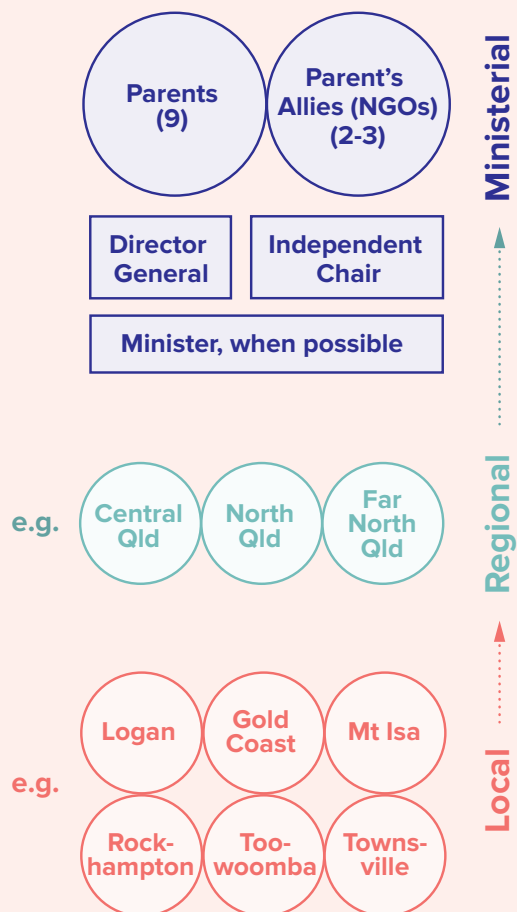
1. An embedded, on-going statewide parent advisory committee

and also...

2. Mandatory legal representation
3. Support (‘early intervention’) that addresses causes – housing, health, Domestic Violence
4. Intensive trauma-informed training for workers.
5. Paid parent advocates (per David Tobis’ three-worker NYC model)

THE STARTING LINE

On Saturday 1 June 2019, parents held their first ever meeting with the Minister. This first meeting was described as ‘the starting line’.

“...it was a time for sharing, connecting, tears and working out what they wanted to share with the Minister. Everyone was ‘on task’ – ready with solutions ... It was especially touching to see everyone supporting one another, the vulnerability of sharing such tender feelings was big, but the courage was bigger!”

1 June 2019

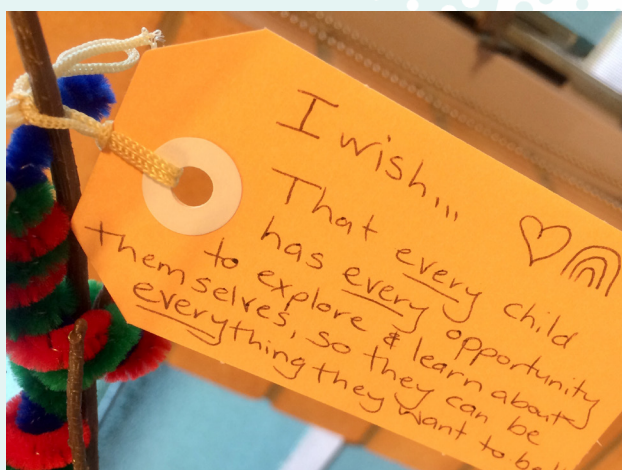
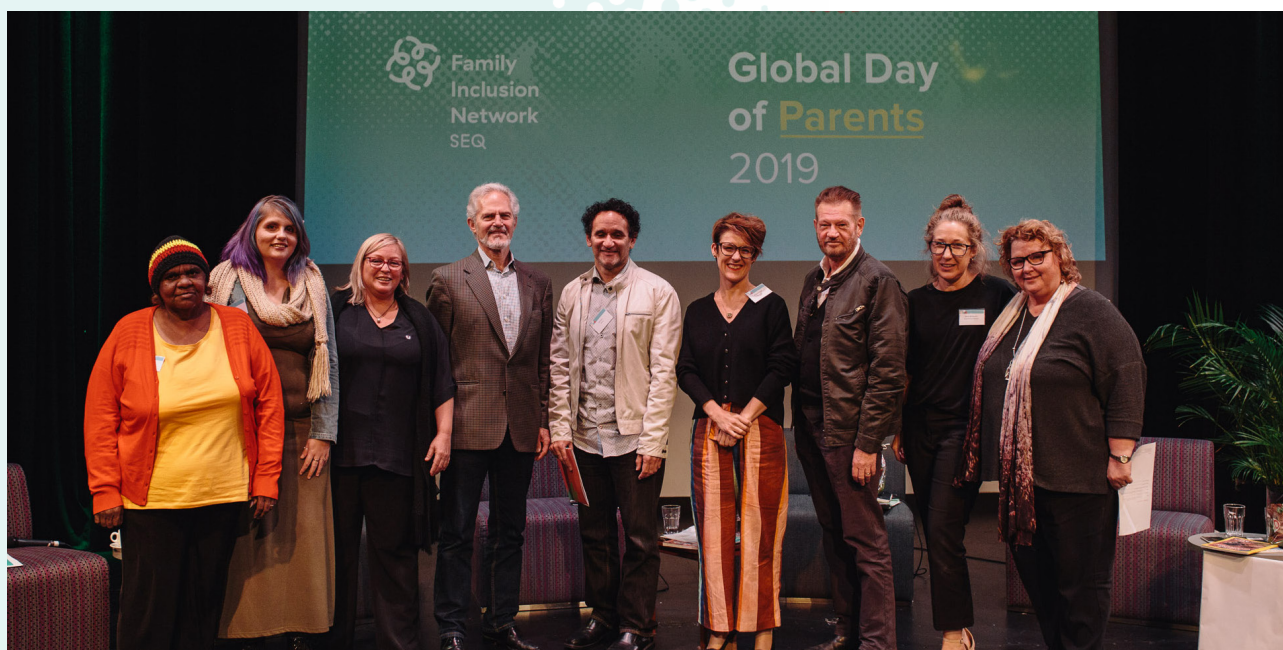
